CATEGORIES OF DATA TREATED

Navigation data

During their normal operation, the computer systems and software procedures used to operate the Website acquire some personal data whose transmission is implicit in the use of Internet communication protocols. This information is not collected to be associated with identified interested parties, but by its very nature could, through processing and association with data held by third parties, allow users to be identified.
